Ordinance No. 1990-07

Passed August 7, 1990

AN ORDINANCE AMENDING SECTION 52.05 OF THE CODE OF ORDINANCES IN THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING IT AN EMERGENCY.

WHEREAS, it has recently come to the attention of the Council of the Municipality of Brookville, Ohio that an ambiguity exists within Section 52.05 regarding unauthorized collection of trash being prohibited;

WHEREAS, it is considered to be necessary for the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio that this Ordinance be passed in an emergency form clarifying such ambiguity.

NOW, THEREFORE, be it ordained by the Council of the Municipality of Brookville, Ohio that:

SECTION I:

Section 52.05 (B) shall be amended to read as follows: It shall be unlawful for any person or employer or agent thereof other than the authorized collector of garbage and trash or other person so authorized by Council, to collect or move or appropriate or dispose of any garbage. A person producing such garbage may place or cause it to be placed in a proper container, however, such person shall still be required to pay for such collection services from the Municipality unless specifically exempted by Council as set forth above.

SECTION II:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, and Resolutions and parts of Resolutions that are in conflict herewith.

SECTION III:

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in full force and effect from and after its passage by a two-thirds majority of council as provided for in the chart of Municipality of Brookville, Ohio.


