AN ORDINANCE AMENDING SECTION 94.03 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, PROVIDING THAT IT BE UNLAWFUL FOR ANY OWNER OR OCCUPANT OF ANY PREMISES LOCATED WITHIN THE MUNICIPALITY TO PERMIT ANY PERSON UNDER 21 YEARS OF AGE TO CONSUME ALCOHOLIC BEVERAGES ON THE PREMISES, AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT

## SECTION I:

Section 94.03 of the Municipal Code of Ordinances be amended to read as follows:

(J) No person that is the owner or occupant of any premises located within the Municipality of Brookville, Ohio, shall:

1. Knowingly permit any person under the age of twenty-one (21) years to remain on the said premises while that person is violating Subsection D hereof which prohibits possession of or consumption of intoxicating liquor by such underaged person or knowingly to permit any person under twenty (20) years of age to remain on the premises while that person is violating Subsection C hereof which prohibits possession or consumption of beer or other intoxicating liquor by such underaged person; or

2. Negligently allow any person under the age of 21 years on the said premises while that person is violating Subsection D hereof which prohibits possession or consumption of intoxicating liquor by such underaged person, or negligently to allow a person under the age of twenty (20) years to remain on said premises while that person is violating Subsection C hereof which prohibits possession or consumption of beer or intoxicating liquor by such underaged person.

## SECTION II:

Who ever shall violate this Section (Section 94.03 J) is guilty of a misdemeanor of the first degree as provided for in the General Penalty Section of the Code of Ordinances in the Municipality of Brookville, Ohio.

All other provisions of Section 94.03 not herein expressly amended shall remain in full force and effect.

## SECTION IV:

This Ordinance shall take effect immediately and be in full force and effect from and after the earliest period allowed by law, it being determined that this is in the best interests for the safety & welfare of the citizens of Brookville, Ohio
