Ordinance No. 1989-02

Passed JANUARY 17, 1989

AN ORDINANCE AMENDING SECTION 94.03 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, PROVIDING THAT IT BE UNLAWFUL FOR ANY PERSON UNDER THE AGE OF 21 YEARS TO ORDER, PAY FOR, SHARE THE COST OF OR ATTEMPT TO PURCHASE ANY INTOXICATING LIQUOR OR POSSESS ANY INTOXICATING LIQUOR IN ANY PUBLIC PLACE AND FURTHER PROVIDING THAT IT BE UNLAWFUL FOR ANY PERSON UNDER THE AGE OF 20 YEARS TO ORDER, PAY FOR, SHARE THE COST OF OR ATTEMPT TO PURCHASE ANY BEER OR INTOXICATING LIQUOR OR POSSESS ANY BEER OR INTOXICATING LIQUOR IN ANY PUBLIC PLACE, AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT

SECTION I:

Section 94.03 of the Municipal Code of Ordinances be amended to read as follows:

No person under the age of 21 years shall order, pay for, share the cost of, or attempt to purchase any intoxicating liquor, either from a sealed or unsealed container or by the glass or by the drink, or possess any intoxicating liquor in any public place.

SECTION II:

Section 94.03 of the Municipal Code of Ordinances be amended to read as follows:

No person under the age of 20 years shall order, pay for, share the cost of, or attempt to purchase any beer or intoxicating liquor, either from a sealed or unsealed container or by the glass or by the drink, or possess any beer or intoxicating liquor in any public place.

SECTION III:

Who ever shall violate these Sections is guilty of a misdemeanor of the first degree as provided for in the General Penalty Section of the Code of Ordinances in the Municipality of Brookville, Ohio.

SECTION IV:

All other provisions of Section 94.03 not herein expressly amended shall remain in full force and effect.
