AN ORDINANCE AMENDING SECTION 92.30 OF THE MUNICIPAL CODE OF ORDINANCES OF BROOKVILLE, OHIO, BY AMENDING THE DEFINITION OF JUNK AND DECLARING IT AN EMERGENCY.

WHEREAS, numerous motor vehicles have been left in an inoperable and unlicensed state within the municipal limits of Brookville, Ohio; and

WHEREAS, it has been previously determined that such vehicles are a nuisance and therefore a danger to the general health and welfare of the community; and

WHEREAS, as a result of certain wording contained within the definition junk, questions have been raised as to what is a junk motor vehicle; and

WHEREAS, it is deemed necessary for the public, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio, to redefine that definition of the word junk and declare it an emergency.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT

SECTION I:

The Section 92.30 of the Municipal Code of Ordinances with respect to the word junk shall be amended to read as follows:

"Junk." Old or scrap copper, brass, rope, rags, batteries, paper, rubber, lumber, pipe, used building materials and roofing, old scrap iron, steel or other ferrous or nonferrous materials. This definition shall also include an inoperable, dismantled, partly dismantled or wrecked motor vehicle or parts thereof or any motor vehicle which is of no value except for salvage or junk purposes or any motor vehicle which is unlicensed or not currently licensed for a period of seven (7) days or more.

SECTION II:

This Ordinance is hereby declared an emergency in order to preserve the public health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and therefore shall take effect immediately upon passage by two-thirds (2/3) of the majority of Council.
