Ordinance No. 1989-16

Passed DECEMBER 19 1989

AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 52.10, PAR. A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL REFUSE CUSTOMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The rates charged by the Municipality of Brookville for trash and garbage collection shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective on the January, 1990 billing for refuse collection for December, January and February:

CLASS I: The minimum charge to be paid by each dwelling unit or business place having not more than one cubic yard or less of garbage and trash per week or needing not more than one stop per week. Rate to be \$18.00 per quarter.

The above amount of trash and garbage per week and the number of collections per week shall be averaged for a three-month period.

SECTION II:

The rates charged by the Municipality of Brookville for trash and garbage collection shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective on the January, 1991 billing for refuse collection for December, January and February.

CLASS 1: The minimum charge to be paid by each dwelling unit or business place having not more than one cubic yard or less of garbage and trash per week or needing not more than one stop per week. Rate to be \$21.00 per quarter.


The above amount of trash and garbage per week and the number of collections per week shall be averaged for a three-month period.


