Ordinance No. 1987-01

Passed JANUARY 6, 19 87

AN ORDINANCE TO PROVIDE AN ADDITIONAL STOP STREET WITHIN THE MUNICIPALITY OF BROOKVILLE, OHIO, BY MEANS OF ADDING A STOP SIGN AND DECLARING AN EMERGENCY.

WHEREAS, Flanders Avenue and Coronado Drive have recently been extended so that they now currently intersect; and

WHEREAS, no traffic control device has ever been erected or scheduled to be erected under the Ordinances of the Municipality of Brookville, Ohio, for this particular intersection; and

WHEREAS, it is now deemed necessary for the safety and welfare of the Municipality of Brookville, Ohio, for the council of the Municipality of Brookville, Ohio, to designate the intersection of Flanders Avenue and Coronado Drive as a one-way stop street and to direct the Municipal Manager to erect a stop sign at the said intersection.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

SECTION I.

The intersection of Flanders Avenue and Coronado Drive should be made a one-way stop street and the stop sign shall be erected on the northwest corner of the intersection at Flanders Avenue and Coronado Drive within the Municipality of Brookville, Ohio, the said stop sign to face toward south bound traffic on Coronado Drive.

SECTION II.

This ordinance is hereby declared to be an emergency ordinance in order to preserve the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and be in full force from and after the date it has been passed according to the charter of the Municipality of Brookville, Ohio.

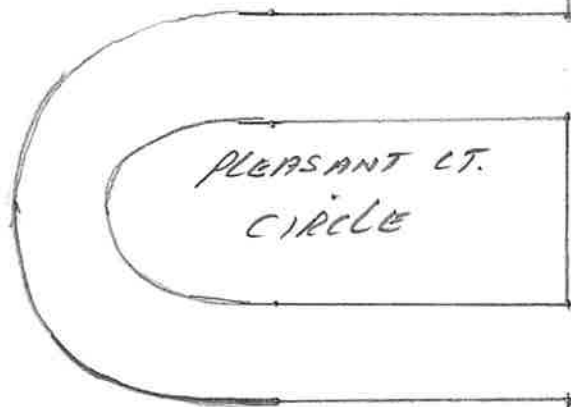
