

# RECORD OF ORDINANCES

Ordinance No. 1987-08

Passed September 15, 1987

AN ORDINANCE TO PROVIDE ADDITIONAL NO PARKING ZONES ON STREETS WITHIN THE MUNICIPALITY OF BROOKVILLE, OHIO, SPECIFICALLY ON WOLFCREEK PIKE FROM McMACKEN LANE NORTH TO ARLINGTON ROAD ON BOTH SIDES OF THE ROADWAY AND ON ARLINGTON ROAD FROM RONA PARKWAY NORTH TO THE RAILROAD TRACKS ON BOTH SIDES OF THE ROADWAY AND DECLARING AN EMERGENCY.

WHEREAS, the traffic patterns have been increased on Wolfcreek Pike and Arlington Road; and

WHEREAS, as a result of the necessity to provide for an even flow of the traffic patterns, it is necessary to declare certain areas as being no parking zones along those roadways; and

WHEREAS, it is now deemed necessary for the safety and welfare of the Municipality of Brookville, Ohio, and for its citizens, for the Council of the Municipality of Brookville, Ohio, to designate certain areas of Wolfcreek Pike and Arlington Road as being no parking zones.

NOW, THEREFORE, be it ordained by the Council of the Municipality of Brookville, Ohio, that:

## SECTION 1.

Arlington Road from Rona Parkway north to the railroad tracts on both sides of the roadway shall hereby be declared no parking zones and appropriate signs and markings shall be posted identifying these areas as being no parking zones.


## SECTION II.

Wolfcreek Pike from McMacken Lane north to Arlington Road on both sides of the roadway shall hereby be declared no parking zones and appropriate signs and markings shall be posted identifying these areas as being no parking zones.

## SECTION III.

This Ordinance is hereby declared to be an emergency ordinance in order to preserve the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and be in full force from and after the date has been passed according to the charter of the Municipality of Brookville, Ohio.
