Ordinance No. 1987-09

Passed October 20, 1987

AN ORDINANCE REPEALING SECTION 33.001 THRU 33.137 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO AND REPLACING THE SAME BY PROVIDING FOR THE DIRECTOR OF POLICE OF THE BROOKVILLE POLICE DEPARTMENT TO ADOPT VARIOUS DEPARTMENTAL RULES AND REGULATIONS FOR THE POLICE DEPARTMENT AND FURTHER PROVIDING FOR AN AUXILIARY POLICE DEPARTMENT AND DECLARING AN EMERGENCY.

WHEREAS, it has come to the attention of the Council of the Municipality of Brookville, Ohio that the present Ordinances regarding the Police Department of the Municipality of Brookville, Ohio are inadequate; and

WHEREAS, it appears that it is necessary for the safety and welfare and health of the citizens of Brookville, Ohio, to adopt a more flexible plan with regards to departmental policies.

NOW, THEREFORE, be it ordained by the Council of the Municipality of Brookville, Ohio, that:

SECTION 1.

The Director of Police of the Brookville Police Department shall establish rules and regulations for policies and procedures to assist in the proper and efficient operation of the Police Department, also its rules to either supplement or co-exist the statutes of the State of Ohio and the Ordinances contained within the Brookville Code of Ordinances, it being expressly understood that such rules and regulations and policies and procedures shall not conflict with any such Ordinances or Statutes.

SECTION II.

All departmental rules and regulations and any amendment or revision thereto shall first be approved by the municipal manager and once so approved, shall be binding upon all employees employed directly by the Brookville Police Department.

SECTION III.

There is currently established an Auxiliary Police Unit within the Police Department of the Municipality of Brookville and the Director of Police shall be the executive head of the Auxiliary Police Unit and he shall be entitled to appoint as many Auxiliary Police Officers as he deems necessary provided they comply with the rules and regulations and policies and procedures of the Brookville Police Department. All appointments to be approved by the Municipal Manager.

SECTION IV.

This Ordinance is hereby declared to be an emergency ordinance in order to preserve the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and be in full force from and after the date has been passed according to the charter of the Municipality of Brookville, Ohio.


