Ordinance No. 1986-02

Passed JANUARY 21, 1986

AN ORDINANCE AMENDING SECTION 35.04 and 35.06 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Section 35.04 shall be amended to read as follows:

All municipal employees employed on a full-time basis shall receive the following paid holidays: New Years Day (8 hours), President's Day also known as Washington's Birthday Observance (8 hours), Good Friday (8 hours), Memorial Day (8 hours), Independence Day (8 hours), Labor Day (8 hours), Thanksgiving Day (8 hours), a one-half day of Christmas Eve (4 hours), Christmas Day (8 hours), and one-half day on New Years Eve (4 hours). All municipal employees employed by the Municipality pursuant to the terms of any union contract shall be excepted from this Ordinance, and shall be allowed only those holidays as provided under the terms of the union contract.

All employees scheduled or required to work on a holiday shall be compensated at straight time rates for time worked in addition to all holiday pay.

In addition to those holidays listed above, all municipal employees, excepting municipal employees under union contract, shall receive three days (8 hours per day) of personal leave with pay upon request to and approval by the employee's supervisor, provided that the request for personal time is received by the supervisor at least twenty-four (24) hours in advance of the date requested. In the case of an employee employed pursuant to the terms of union contract, the terms of that contract shall be applied to any such personal days so allowed.

All permanent part-time municipal employees shall be granted one personal day for each six (6) month period completed in that capacity during the following six (6) month period. (No carry over on this personal day allowed.)

SECTION II:

Section 35.06 shall be amended to read as follows:

(G) All permanent part-time municipal employees shall be eligible for sick leave pay under the same terms and conditions as established under 35.06 of the Code of Ordinances of the Municipality of Brookville, Ohio, for all full-time municipal employees. Sick leave shall accumulate at the same rate of 4.6 hours for each completed 80 hours of service for all permanent part-time employees.

SECTION III:

This Ordinance shall rescind any and all ordinances or resolutions or any parts thereof that may be in conflict herewith.

SECTION IV:

This Ordinance shall take effect as of January 1, 1986.


SECTION V:

This Ordinance is hereby declared to be an emergency ordinance, the reason for the emergency being the proper employment of its municipal employees to preserve the public health, safety and welfare of the citizens of the Municipality and therefore this Ordinance shall take effect and be in force from and after its passage, provided passage is by at least two-third of the members of council.
