Ordinance No. 1986-14

Passed December 16, 1986

AN ORDINANCE AMENDING SECTION 35.30 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, the Municipality of Brookville, Ohio, has created an Ordinance regarding holiday benefits for Municipal employees; and

WHEREAS, it has become apparent that it would be in the best interest of the safety and welfare of the citizens of the Municipality of Brookville, Ohio, to amend the said Ordinance by providing certain provisions for Sergeants and Patrolmen of the Police Department of the Municipality of Brookville, Ohio.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Section 35.30, Paragraph (F) of the Code of Ordinances of the Municipality of Brookville, Ohio, be amended to include the following provision: All regular full-time Sergeants and Police Patrolmen of the Municipality of Brookville, Ohio, shall be eligible to convert all or any portion of their full days of unused personal days to which they are entitled under Section 35.30, Paragraph (D) to a cash payment at a regular hourly straight pay rate minus all normal deductions. In the event that the said Policeman desire to make such a conversion, they shall notify the Director of Police of their decision, in writing before December 1st of each calendar year, the said notification to include the specific number of days that they wish to have converted to a cash payment. Said payment shall be made in December of that year only.

SECTION II:

Section 35.30 of the Code of Ordinance of the Municipality of Brookville, Ohio, be amended to include the following provision: Paragraph (G) All regular full-time Sergeants and Police Patrolman of the Municipality of Brookville, Ohio shall be granted twelve (12) Personal Days, ninety-six (96) hours, for each year.

Probationary employee shall be granted one (1) personal day, eight (8) hours, for each month of service up to a total of twelve (12) days for the year. Personal Days will be granted each calendar year and none shall be carried over into the following year.

The Director of Police must approve an employee's request for a Personal Day at least three (3) days in advance. No more than two (2) Personal Days, sixteen (16) hours, shall be granted during a month.

As now in these policies Personal Days shall mean scheduled work periods during which employee can not request to work, but for which they are paid their regular rate of pay and which are in lieu of Holidays.

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and be in force from and after its passage.
