AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBER OF LOTS OF THE VILLAGE OF BROOKVILLE, OHIO FROM THEIR PRESENT CLASSIFICATION TO THE NEW CLASSIFICATION OF B-3.

Situate in the Village of Brookville, County of Montgomery, State of Ohio and being a part of a 0.685 acre tract conveyed to Robert E. Behnken, by deed, recorded in Microfiche Volume 74-347C01 and part of a 1.208 acre tract conveyed to Robert E. Behnken, by deed, recorded in Microfiche Volume 74-98C02 of the deed records of said county.

Beginning at an iron pin in the south line of the said 0.685 acre tract, in the north line of Rona Parkway Drive, said iron pin being South  $87^{\circ} 02' 40''$  East a distance of 90.00 feet from the southwest corner of the said 0.685 acre tract, which corner is the northeast corner of Rona Parkway Drive and Coronado Drive; thence, from said point of beginning, 90.00 feet eastwardly from and parallel with the west line of the said 0.685 acre tract, North  $2^{\circ} 57' 20''$  East a distance of 149.79 feet to an iron pin in the north line of the said 0.685 acre tract; thence, with the north line of the said 0.685 acre tract and the north line of the said 1.208 acre tract, South  $86^{\circ} 58' 58''$  East, passing the northeast corner of the said 0.685 acre tract and the northwest corner of the said 1.208 acre tract at 107.11 feet, a distance of 125.00 feet to an iron pin; thence, by a new division line through the said 1.208 acre tract, South  $2^{\circ} 57' 20''$  West a distance of 149.66 feet to an iron pin in the south line of the said 1.208 acre tract and in the north line of Rona Parkway Drive; thence, with the south line of the said 1.208 acre tract and the south line of the said 0.685 acre tract and the north line of Rona Parkway Drive, North  $87^{\circ} 02' 40''$  West, passing the southwest corner of the said 1.208 acre tract and the southeast corner of the said 0.685 acre tract at 13.65 feet, a distance of 125.00 feet to the place of beginning containing 0.430 acres, more or less, of which 0.375 acres are out of the 0.685 acre tract and 0.055 acres are out of the 1.208 acre tract.

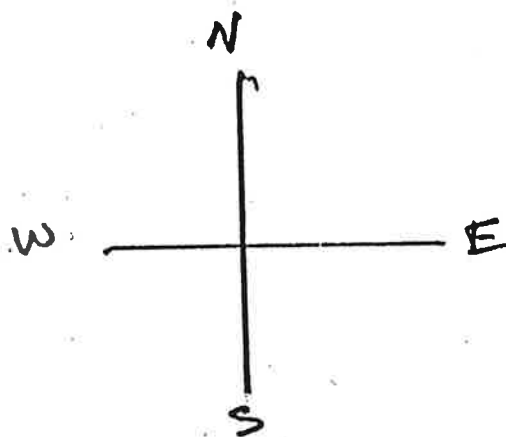
**REPORT ON
