Ordinance No. 1985-08

Passed August 6, 1985

AN ORDINANCE VACATING AN ALLEY LOCATED OFF Sycamore Street in the Municipality of Brookville, Ohio.

Whereas, it appears to the council that there is no just reason to continue maintaining an alley located within the Municipality of Brookville, Ohio, and being a 12 foot alley off of Sycamore Street between two parcels of real estate which currently front Hay Street, Sycamore Street, and Market Street; and

Whereas, it appears that there is a good cause for vacating that portion of the alley so described above and that it shall not be detrimental to the general interest if it is so vacated and therefore should be vacated.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT

Section I:

That the 12 foot alley which is currently located just off of Sycamore Street separating two parcels of real estate owned by Philip Macy, the said parcels fronting Market Street, Sycamore Street, Hay Street, be and the same is hereby vacated.

Section II:

The Municipal Engineer is hereby instructed to prepare a vacation of plat of the said vacated alley and that the Clerk of Council is instructed to endorse upon such plat, the action of this Council is vacating such portion of the alley to cause the plat to be recorded in the office of the Recorder of Montgomery County, Ohio, and to notify the auditor of Montgomery County, Ohio, the vacation of that said same alley.

Section III:

This Ordinance shall rescind any and all ordinances or resolutions or any parts thereof that may be in conflict herewith.

Section IV:

This Ordinance shall take effect upon passage pursuant to the Charter of the Municipality of Brookville, Ohio.
