AN ORDINANCE APPROVING VARIOUS AMENDMENTS MADE TO THE CODIFICATION OF THE ORDINANCE OF THE MUNICIPALITY OF BROOKVILLE, OHIO, ADDING NEW MATTER REPEALING VARIOUS ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Ordinances of the Municipality of Brookville, Ohio, have been amended since the Code of Ordinances of the Municipality of Brookville, Ohio, was adopted on September 2, 1980; and

WHEREAS, Council has by majority vote authorized the Municipal Manager to contract with the American Legal Publishing Company to codify various amendments to the Code of Ordinances of the Municipality of Brookville, Ohio, to make various changes in the Code of Ordinances to bring them in compliance with the Ohio Revised Code; and

WHEREAS, the American Legal Publishing Company has completed making various changes in supplements to the Code of Ordinances of the Municipality of Brookville, Ohio pursuant to that contract; and

WHEREAS, it is necessary for the public peace, health, safety and welfare of the Municipality and for its citizens to have its Code of Ordinances updated; and

WHEREAS, Council now desires to approve such amendments and updating of the codification.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

The general and permanent ordinances of the Municipality of Brookville, Ohio, hereinafter referred to as the Brookville Municipal Court of Ordinances, so revised, ranged and compiled and numbered as to section and codified and updated through Ordinance 1985-03, I hereby approved, adopted and enacted.

## SECTION II:

The updated Brookville Municipal Code of Ordinances contains all of the provisions of a general and permanent nature pertaining to the subjects therein enumerated and embraced. All prior Ordinances, and parts of Ordinances which are incorporated in or pertain to the subjects

enumerated and embraced in the Brookville Code of Ordinances of the Municipality of Brookville, Ohio as updated are hereby repealed effective upon passage of this Ordinance.

## SECTION III:

The repeal of Ordinances as provided in Section II hereof shall not affect the following:

- A. All ordinances of a temporary or special nature, and all other ordinances pertaining to subjects not enumerated or embraced in the Brookville Municipal Code of Ordinances;
- B. Any offense or act committed or done or any penalty or forfeiture incurred, or any contract or right established accruing before the passage of this Ordinance;
- C. Any ordinance or resolution, promising or guaranteeing the payment of money to or by the Municipality, authorizing the issuance of any bonds, or notes of the Municipality or any other evidence of the Municipality's indebtedness, or any contract or obligation assumed by the Municipality;
- D. The administrative ordinances or resolutions of this Council not in conflict or inconsistent with the provisions of the Brookville Municipal Code of Ordinances;
- E. Any right or franchise conferred by any ordinance or resolution of this Council to any person or corporation;
- F. Any ordinance naming, relocating or vacating any street or public way, or any ordinance identifying stop streets at intersections, one-way streets or any other traffic regulations;
- G. Any ordinance levying or imposing taxes, assessments, or charges;
- H. Any ordinance fixing salaries, wage rates, fringe benefits or other employments or compensation of City officers and employees;

- I. Any prosecution, suit or other proceeding pending, or any judgment rendered on or prior to the effective date of this Ordinance;
- J. Any ordinance which may be adopted by this Council after the effective date of this Ordinance.

## SECTION IV:

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare. It shall therefore take effect immediately upon passage by two-thirds of the members of Council.
