

# RECORD OF ORDINANCES

Ordinance No. 1985-10

Passed September 3, 1985

AN ORDINANCE TO PROVIDE ADDITIONAL STOP STREETS WITHIN THE MUNICIPALITY OF BROOKVILLE BY MEANS OF ADDING STOP SIGNS OR RELOCATING STOP SIGNS AND DECLARING AN EMERGENCY.

WHEREAS, Carr Drive was dedicated as an official street of the Municipality of Brookville, Ohio, on September 4, 1973, and,

WHEREAS, no traffic control device has ever been erected or scheduled to be erected under the Ordinances of the Municipality of Brookville, Ohio, and

WHEREAS, it is now deemed necessary for the safety of the uses of the municipal streets for the council of the Municipality of Brookville, Ohio, to designate additional streets as stop streets within the Municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

The intersection of Albert Road and Carr Drive shall be made a one-way stop street and a stop sign shall be erected on the northeast corner and southeast corner of Carr Drive at said intersection of Carr Drive and Albert Road facing toward west bound traffic.

## SECTION II:

The stop sign shall be erected on Carr Drive (south) where an intersection of Carr Drive (north) facing west bound Carr Drive south traffic.

## SECTION III:

Stop signs shall be erected on Carr Drive (north) where it intersects with Carr Drive (south) facing south west bound traffic on Carr Drive (north). A diagram of the location of the said stop signs as set forth in Sections I through III of this Ordinance is hereby attached and made a part hereof.

## SECTION IV:

This Ordinance is hereby declared to be an emergency Ordinance in order to preserve the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and


