Ordinance No. 1985-14

Passed December 17, 1985

AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 50.30, PARAGRAPH A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL WATER CONSUMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

There shall be a minimum charge in case of water billed quarterly for the first 1,000 cubic feet consumed per quarter, which minimum charge is to cover investment, overhead expense and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters for the year designated.

These rates shall start and be in effect on the January billing of each year as indicated for the water consumed during the previous quarter on September through November.

It is hereby declared to be the intention of the Council of the Municipality of Brookville that this Ordinance would have been adopted has such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
