Ordinance No. 1985-15

Passed December 17, 1985

AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 51.20, PARAGRAPH B-1 - AN ORDINANCE FIXING RATES AND CHARGES FOR THE SANITARY SEWER SYSTEM AND SEWAGE TREATMENT PLANT SERVICE TO THE MUNICIPALITY OF BROOKVILLE, OHIO, ITS INHABITANTS AND OTHER USERS.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

The following shall be the quarterly rates charged by the Municipality of Brookville for services rendered or to be rendered by its sanitary sewerage system to it and to its inhabitants and others, based on water consumption as follows:

First	Minimum charge for 1300 cubic feet or less per quarter - \$10.50
Next	2200 cubic feet per quarter - 90¢ per 100 cubic feet
Next	3000 cubic feet per quarter - 75¢ per 100 cubic feet
Next	3500 cubic feet per quarter - 55¢ per 100 cubic feet
Next	3500 cubic feet per quarter - 35¢ per 100 cubic feet
All over 13500 cubic feet per quarter	- 18¢ per 100 cubic feet

## SECTION II:

These rates shall start and be in effect on the January 1986 billing for sewer usage during the previous quarter of September through November, 1985.

## SECTION III:

If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall affect only such clause, sentence, section or part of this Ordinance and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this Ordinance. It is hereby declared to be the intention of the Council of the Municipality of Brookville that this Ordinance would have been adopted has such unconstitutional, illegal or invalid sentence, clause, section or part hereof not been included herein.
