

# RECORD OF ORDINANCES

Ordinance No. 1985-16

Passed December 17, 1985

AN ORDINANCE TO PROVIDE STOP SIGNS AT CERTAIN STREETS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING THIS AN EMERGENCY.

WHEREAS, it is deemed necessary for the safety of the users of the Municipal streets for the Council to designate another street as a stop street.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

## SECTION I:

The intersection of Sunrise Avenue and Mound Street, in the Municipality of Brookville, Ohio, be made a two-way stop street, and further that two stop signs be erected; one at the Southeast corner of the intersection of Sunrise Avenue and Mound Street facing North bound traffic; and that a stop sign be erected on the Northwest corner facing South bound traffic, thereby making the intersection of Sunrise Avenue and Mound Street a two-way stop.

## SECTION II:

The intersection of Edgebrook Avenue and Sunrise Avenue in the Municipality of Brookville, Ohio, be made a one-way stop street, and further that one stop sign be erected at the Southwest corner of the intersection of Edgebrook Avenue and Sunrise Avenue facing East bound traffic, thereby making the intersection of Edgebrook Avenue and Sunrise Avenue a one-way stop.

## SECTION III:

The intersection of Carter Court and Edgebrook Avenue in the Municipality of Brookville, Ohio, be made a one-way stop street, and further that one stop sign be erected at the Southeast corner of the intersection of Carter Court and Edgebrook Avenue facing North bound traffic, thereby making the intersection of Carter Court and Edgebrook Avenue a one-way stop.

## SECTION IV:

The intersection of Edgebrook Avenue and Flanders Avenue in the Municipality of Brookville, Ohio, be made a one-way stop street, and further that one stop sign be erected at the Southeast corner of the intersection of Edgebrook Avenue and Flanders Avenue facing North bound traffic, thereby making the intersection of Edgebrook Avenue and Flanders Avenue a one-way stop.

## SECTION V:

The intersection of Flanders Avenue and Arlington Road in the Municipality of Brookville, Ohio, be made a one-way stop street, and further that one stop sign be erected at the Southwest corner of the intersection of Flanders Avenue and Arlington Road facing East bound traffic, thereby making the intersection of Flanders Avenue and Arlington Road a one-way stop.

## SECTION VI:




## SECTION VII:
