

# RECORD OF ORDINANCES

DAYTON BLANK BOOK CO. INC.

Ordinance No. 1984-01

Passed JANUARY 3, 1984

AN ORDINANCE TO PROVIDE A FOUR-WAY STOP INTERSECTION AT MAIN STREET AND SALEM STREET BY MEANS OF STOP SIGNS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING THIS AN EMERGENCY.

WHEREAS, it is deemed necessary for the safety of the users of the Municipal streets for the Council to designate another street as a stop street.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

### SECTION I:

The intersection of Main Street and Salem Street, in the Municipality of Brookville, Ohio, be made a four-way stop street, and further that four stop signs be erected; one at the Northeast corner of the intersection of Main Street and Salem Street facing West bound traffic; that a stop sign be erected at the Southwest corner of Salem Street and Main Street facing North bound traffic; that a stop sign be erected on the Southeast corner facing East bound traffic; and that a stop sign be erected on the Northwest corner facing South bound traffic, thereby making the intersection of Main Street and Salem Street a four-way stop.

### SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance to the immediate preservation of public peace, health, safety, and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in force from and after its passage.

### SECTION III:

This Ordinance shall rescind any part of any other Ordinance that is in conflict herewith.
