Ordinance No. 1984-05

Passed June 5, 1984

AN ORDINANCE AMENDING SECTION 33.013(B) OF THE CODE OF ORDINANCES OF THE CITY OF BROOKVILLE AND DECLARING AN EMERGENCY.

WHEREAS, the City of Brookville has found it necessary to use auxiliary police officers in order to supplement its police force of the Municipality of Brookville; and

WHEREAS, such an increase is necessary for the welfare and public safety of the citizens of the Municipality of Brookville, Ohio; and

WHEREAS, the current residential restriction as currently set forth in Section 33.013(B) places restrictions on the auxiliary police department which are currently creating a great deal of difficulty in filling the auxiliary police department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Section 33.013(B) of the Code of Ordinances of the Municipality of Brookville, Ohio, shall be amended to read as follows: Each auxiliary police officer shall reside within a 15 mile radius centered upon the Municipality of Brookville, Montgomery County, Ohio.

SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance in order to protect the general health and welfare of the community and its environs and therefore, this Ordinance shall take effect and be enforced from and after its passage by the members of council as pursuant to Section 4.07(A)(5) of the municipal charter.
