Ordinance No. 1983-01

Passed January 4, 1983

AN ORDINANCE TO PROVIDE AN ADDITIONAL STOP STREET BY MEANS OF STOP SIGNS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING THIS AN EMERGENCY.

WHEREAS, it is deemed necessary for the safety of the users of the Municipal streets for the Council to designate another street as a stop street.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

## SECTION I:

That Orchard Street, in the Municipality of Brookville, be made a stop street for **South** bound traffic at the intersection of Orchard Street and Simmons Street and further that a stop sign be erected at the Northwest corner of the intersection of Orchard Street and Simmons Street facing toward north bound Orchard Street traffic, and that Simmons Street be made a stop street for both **East** bound and **West** bound traffic at the intersection of Orchard Street and Simmons Street, and further that a stop sign be erected at the Northeast corner of the intersection of Orchard Street and Simmons Street facing toward **West** bound Simmons Street traffic and that a stop sign be erected at the Southwest corner of Orchard Street and Simmons Street, across the street from the Northwest stop sign referred to above, facing toward **East** bound Simmons Street traffic, thereby making the center section of Simmons Street and Orchard Street a two-way stop.

## SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance to the immediate preservation of public peace, health, safety, and welfare of the citizens of the Municipality of Brookville, **Ohio**, and this Ordinance shall take effect and be in force from and after its passage.

## SECTION III:

This Ordinance shall rescind any part of any other Ordinance that is in conflict herewith.


