Ordinance No. 1983-05

Passed April 19, 1983

AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 50.30, PAR. A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL WATER CONSUMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

There shall be a minimum charge in case of water billed quarterly for the first 1,000 cubic feet consumed per quarter, which minimum charge is to cover investment, overhead expense and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

MINIMUM CHARGES 1,000 Cubic Feet or Less

1/2 inch meter	24.50 per quarter
5/8 inch meter	24.50 per quarter
3/4 inch meter	27.00 per quarter
1 inch meter	35.00 per quarter
1 1/2 inch meter	50.00 per quarter
2 inch meter	75.00 per quarter
3 inch meter	138.00 per quarter
4 inch meter	204.00 per quarter
6 inch meter	342.00 per quarter
8 inch meter	571.00 per quarter
10 inch meter	938.00 per quarter

The following shall be additional charges:

First	1,000 cubic feet per quarter - Minimum
Next	9,000 cubic feet per quarter - \$9.00 per thousand
Next	90,000 cubic feet per quarter - 8.50 per thousand
Next	400,000 cubic feet per quarter - 8.00 per thousand
All over	500,000 cubic feet per quarter - 7.50 per thousand

SECTION II:

These rates shall start and be in effect on the July 15, 1983 billing for the water consumed during the previous quarter on March through May, 1983

SECTION III:

If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall affect only such clause, sentence, section or part of this Ordinance and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this Ordinance. It is hereby declared to be the intention of the Council of the Municipality of Brookville
