Ordinance No. 1983-20

Passed DECEMBER 6, 1983

AN ORDINANCE AMENDING ORDINANCE NO. 1981-7 BY DELETING THE FIRE OPERATING FUND AS A SEPARATE FUND AND DECLARING AN EMERGENCY.

WHEREAS, it is necessary to comply with certain new principals of accounting, and as required by the State of Ohio with respect to the Fire Operating Fund, and

WHEREAS, it is necessary for the preservation of the public health, safety and welfare of the residents of the Municipality of Brookville, Ohio to delete the Fire Operating Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I

The Fire Operating Fund shall be deleted as a separate fund on December 31, 1983 and any monies remaining in the fund shall be transferred to the General Fund. The Brookville Fire Department will be operated under and funded by the Brookville General Fund starting January 1, 1984.

## SECTION II

The General Fund shall receive fifty (50) percent of all monies received by the Municipality of Brookville, Ohio from payments made pursuant to all fire protection contracts in order to help fund the Fire Department.

## SECTION III

This ordinance shall rescind any ordinances or resolutions or any parts thereof that may be in conflict herewith.

## SECTION IV

This ordinance is hereby declared to be an emergency ordinance, the reason for the emergency being the need to provide proper funding for the Brookville Fire Department which is necessary to preserve the public health, safety and welfare of the citizens of the Municipality of Brookville, Ohio, and shall be enforced from and take effect January 1, 1984, provided passage is by at least two-thirds (2/3) of the members of Council.
