AN ORDINANCE AMENDING SECTION 33.002 AND SECTION 33.003 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, the Municipality of Brookville, Ohio, has recently entered into a contract with the union representing the patrolmen employed by the Municipality of Brookville, Ohio's police department; and

WHEREAS, certain portions of that contract are in conflict with certain ordinances created partially as a result of the previous contract entered into between the Municipality and the union; and

WHEREAS, it is deemed necessary for the safety and welfare of the citizens of the Municipality of Brookville, Ohio, to correct these discrepancies.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Ordinance No. 33.002 (A) shall be ordered amended to read as follows:

(A) The Municipal Manager shall, when provided for by Council, appoint all deputy marshals, policemen, night watchmen, and special policemen. All such officers shall continue in office until removed therefrom for the cause in the matter provided by R. C. Section 737.171.

SECTION II:

Section 33.003 of the Code of Ordinances of the Municipality of Brookville, Ohio, shall be amended to read as follows:

All appointments made under Section 33.002 shall be for a probationary period of one year's continuous service, none shall be made until the appointee has satisfactorily served his probationary period. At the end of the probationary period, the Municipality Manager shall remove or finally appoint the employee.

This Ordinance shall rescind any and all ordinances or resolutions or any parts thereof that may be in conflict herewith.

SECTION IV:

This Ordinance is hereby declared to be an emergency ordinance, the reason for the emergency being the proper employment of its municipal employees, specifically policemen, to preserve the public health, safety and welfare of the citizens of the Municipality and therefore this Ordinance shall take effect and be in force from and after its passage, provided passage is by at least two-thirds of the members of council.
