AN ORDINANCE AMENDING SECTION 33.006 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO BY SETTING FORTH THE NORMAL WORKWEEK - FOR POLICE OFFICERS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND THEIR OVERTIME COMPENSATION AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPALITY OF BROOKVILLE, OHIO THAT:

SECTION I:

Section 33.006 shall be ordered amended to read as follows:

A) The normal work schedule for employees shall consist of eighty (80) hours per pay period. Variations from this schedule due to shift changes and the need for twenty-four (24) hour coverage shall not be cause for premium pay. When the regular schedule of work results in fewer than 2080 hours over a 52-week schedule, the deficit hours shall be scheduled so as to be distributed as evenly as possible over a 12-month period.

B) (1) Employees required to work more than the regularly assigned number of hours during a pay period or more than eight (8) hours per shift shall be compensated at the rate of one and one-half times the employee's base rate of pay for all work over the regularly scheduled number of hours for that pay period when such work is authorized by the Chief or his authorized representative, except as noted herein. Such payment shall be made to the nearest one-half hour.

(2) Overtime will be distributed on an equitable basis from a list which shall initially be established in order of seniority. If an employee cannot be reached to work an overtime assignment, he shall go to the bottom of the overtime list in the same fashion as though he had worked overtime. For purposes of equitable distribution of overtime, time refused on this basis will be credited as overtime worked.

C) Employees called in and required to work at a time disconnected to their regular scheduled hours of work shall be compensated at a minimum of two (2) hours pay at straight time.

Call-in time worked shall be compensated at the rate of time and one-half. The minimum payment shall be the equivalent of two hours straight time pay. Subsequent call-ins shall be similarly compensated if the subsequent call-ins are made after the time span covered by the original call-in.

D) There shall be no pyramiding of premium pay.

E) Any police officer of the Municipality who takes home, after his shift, or carries with him while off duty any portable radio, pager, or any other communication device, shall be deemed to be carrying that device for convenience purposes and shall not be entitled to additional compensable hours of employment or overtime for having that device with him while off duty.

SECTION II:

This Ordinance shall revoke and rescind any Ordinance, parts of Ordinances, Resolutions, parts of Resolutions, that are in conflict herewith and shall take effect and be in force from and after January 1, 1982.

SECTION III:

This Ordinance is hereby declared an emergency Ordinance. The reason for the emergency is being the proper employment of the Municipal employees to preserve the public health, safety, and welfare of the citizens of the Municipality of Brookville, Ohio, and, therefore, this Ordinance shall take effect and be in force from and after its passage, provided passage is by at least two-thirds of the members of Council.
