AN ORDINANCE TO PROVIDE AN ADDITIONAL STOP STREET BY MEANS OF STOP SIGNS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING THIS AN EMERGENCY.

WHEREAS, it is deemed necessary for the safety of the users of the Municipal streets for the Council to designate another street as a stop street.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

## SECTION I:

That Rona Parkway, in the Municipality, be made a stop street for West bound traffic at the intersection of Rona Parkway and Coronada Drive and further that a stop sign be erected at the Northeast corner of the intersection of Rona Parkway and Coronada Drive facing toward West bound Rona Parkway traffic and that Coronada Drive be made a stop street for both North bound and South bound traffic at the intersection of Coronada Drive and Rona Parkway and further that a stop sign be erected at the Northwest corner of the intersection of Coronada Drive and Rona Parkway facing toward Southbound Coronada Drive traffic and that a stop sign be erected at the Southeast corner of the intersection of Coronada Drive and Rona Parkway facing toward Northbound Coronada Drive traffic, thereby making the center section of Coronada Drive and Rona Parkway a three-way stop.

## SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance to the immediate preservation of public peace, health, safety, and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in force from and after its passage.

## SECTION III:

This Ordinance shall rescind any part of any other Ordinance that is in conflict herewith.
