AN ORDINANCE AMENDING SECTIONS 111.01 THROUGH 111.14 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO BY CONSOLIDATING THE ORDINANCES AND INCREASING THE LICENSE FEES FOR MECHANICAL AMUSEMENT DEVICES AND AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO THAT:

Sections 111.01 through 111.14 shall be amended as follows:

SECTION I:

The purpose of this Ordinance, the following definitions shall apply:

"MECHANICAL AMUSEMENT DEVICE" A machine which upon the insertion of a coin or a slug operates or may be operated for use as a game, contest, or amusement of any description; or which may be used for any such game, contest, or amusement of any description; and which includes but not limited to any drawing device, a punch board, pinball machine, video game, pool or billard table, and musical device.

SECTION II:

LICENSE REQUIRED. It shall be unlawful for any person to have in his possession and expose in any public place or operate a mechanical amusement device or a coin-operated device or machine as described in Section I of this Ordinance without obtaining a license therefore from the **Mayor** of the municipality.

SECTION III:

LICENSE FEES.

(A) The Mayor is authorized to issue a license for the operation of a mechanical amusement device as defined in Section I of this Ordinance to any person upon the payment of a license fee for such mechanical amusement device or devices, machine, or machine possessed, exposed or operated in the municipality as follows:

- (1) One pool table or billard table - \$50 per year.
- (2) Each additional pool table or billard table - \$15 per year.
- (3) One mechanical amusement device excluding pool tables or billard tables - \$50 per year.
- (4) Each additional mechanical amusement device ~~ex~~cluding pool table or billard table - \$20 per year.

(B) Any license so issued shall be extended from year to year upon the payment of the license fee or until revoked by the Mayor. A year for the purpose of this Ordinance shall be considered to begin on July 1 and end on June 30.

SECTION IV:

The Mayor upon payment of the fees set forth in Section III shall issue to the licensee a certificate for such mechanical amusement device or pool table. Such certificate shall be consecutively numbered showing the date of issue and signature by the Mayor. Every mechanical amusement device so licensed shall contain such identification marks upon the license for each mechanical amusement device for which a license has been issued, and these identification marks shall be placed by the Mayor upon the certificate. The certificate shall be attached to the mechanical amusement device in a conspicuous place, and in such a manner that it cannot be removed except by the licensee.

SECTION V:

This Ordinance is hereby declared to be an Emergency Ordinance in order to protect the general health and welfare of the community and its environs. Therefore, this Ordinance shall take effect and be in force from and after its passage by the members of Council as pursuant to the Municipal Charter.
