Ordinance No. 1982-13

Passed October 5th 19 82

AN ORDINANCE AUTHORIZING AND DECREEEING A ONE-WAY ALLEY AND THE PLACEMENT OF VARIOUS ONE-WAY SIGNS, IN THE ALLEY PARALLEL TO MARKET AND MAIN STREET BETWEEN JEFFERSON AND COLUMBIA STREET IN THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING AN EMERGENCY.

Whereas, it is deemed necessary for the general safety and welfare of the Municipality of Brookville, Ohio, to create adequate traffic control for various streets and alleys within the Municipality of Brookville, Ohio;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I.

The alley running parallel to and between Market and Main Street to the south of Jefferson and north of Columbia Avenue, within the Municipality of Brookville, Ohio, shall hereinafter declare to be a one-way alley with no entrance being permitted from Columbia Avenue and no exit being permitted on to Jefferson Street. The one-way direction being in a southerly direction from Jefferson Street on to Columbia Avenue.

## SECTION II.

One-way signs shall be placed at the northeast corner of the alley at Jefferson Street and at the southwest corner of Columbia Avenue and the alley and directly behind Rowe's Brookville Party Supply.

## SECTION III.

This Ordinance shall rescind and revoke all ordinances, parts of Ordinances, resolutions and parts of resolutions, that are in conflict here-with.

## SECTION IV.

This Ordinance is hereby declared to be an emergency Ordinance, the reason for the emergency being to provide for necessary traffic control within the Municipality which is necessary to preserve the public health, safety and welfare of the Municipality, therefore, this Ordinance shall take effect and be in force from and after its passage, provided passage is by at least two-thirds of the members of Council.


