AN ORDINANCE RESCINDING ORDINANCE 1982-13 WHICH AUTHORIZED AND DECREED A ONE-WAY ALLEY AND THE PLACEMENT OF VARIOUS ONE-WAY SIGNS, IN THE ALLEY PARALLEL TO MARKET AND MAIN STREET BETWEEN JEFFERSON AND COLUMBIA STREET IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, the Municipality of Brookville deemed it necessary to create a certain one-way alley in the Municipality; and

WHEREAS, various unforeseen problems have occurred as a result; and

WHEREAS, it is deemed necessary for the general welfare and safety of the Municipality of Brookville, Ohio, to rescind that earlier decision in order to create adequate traffic control for the streets and alleys within the Municipality of Brookville, Ohio;

NOW THEREFORE, be it ordained by the Council of the Municipality of Brookville, Ohio; that:

## SECTION I.

Ordinance 1982-13 is hereby ordered rescinded and all one-ways signs erected at the northwest corner of the alley at Jefferson Street and the Southwest corner of Columbia Avenue and the alley and directly behind Rowe's Brookville Party Supply are hereby ordered removed.


## SECTION II.

This Ordinance is hereby declared to be an Emergency Ordinance, the reason for the emergency being the necessity to provide adequate traffic control within the Municipality which is necessary to preserve the public health, safety and welfare of the Municipality, therefore, this Ordinance shall take effect and shall be in force from and after its passage, provided passage is by at least two-thirds of the members of Council.
