AN ORDINANCE TO ACCEPT AN EASEMENT FROM RONA VILLAGE HOMEOWNERS ASSOCIATION CONCERNING STORM, SANITARY SEWER, AND WATER LINES.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO THAT:

## SECTION I:

An easement granted by Rona Village Home Owners Association to the Municipality of Brookville, Ohio, granting the right of way to lay, maintain, operate, repair, and remove sanitary sewer, and water lines, and fixtures and equipment appurtenances thereto through and under the real estate described in Section II below, is hereby approved and accepted.

## SECTION II:

The easement so conveyed is described as follows:

Situate in the Village of Brookville, County of Montgomery, State of Ohio, and being lot numbered 1395 of Rona Village Brookville, Section 1, as the same is designated, numbered and known on the recorded plat hereof, Plat Book 86, Page 62 and 63 of the Plat Records of Montgomery County, Ohio, being all the lot numbered 1409 of Rona Village Brookville, Section 2A as the same is designated, numbered and known on the recorded plat hereof, Plat Book 92, Page 12, and being all of lot numbered 1462 of Rona Village Brookville, Section 2B as the same is designated, numbered and known on the recorded plat hereof, Plat Book 98, Page 58 of the Plat Records of Montgomery County, Ohio.

## SECTION III.

The Clerk is hereby instructed and authorized to endorse the acceptance of such easement upon the instrument and cause the same to be recorded in the office of the County Recorder of Montgomery County, Ohio.

## SECTION IV:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, Resolutions, parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.
