AN ORDINANCE AMENDING ORDINANCE NO. 490, OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO BY ESTABLISHING A NEW WAGE SCALE FOR MUNICIPAL EMPLOYEES AND TO DECLARE THIS AN EMERGENCY.

WHEREAS, it is deemed necessary for the general safety and welfare of the Municipality of Brookville, Ohio, that new wage scale regulations be established, and that this Ordinance be deemed an Emergency Ordinance and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Ordinance No. 490 is hereby ordered to be amended to read as follows: The following constitutes a wage scale for all employees of the Municipality with exception to those employees of the Police Department who are employed as Police Patrol Persons or Probationary Police Patrol Persons;

All part-time employees of the Municipality shall begin their employment with the Municipality at the wage which is set forth in Step A of their respective work classification.

The wage scale for those Patrol Persons and Probationary Patrol Persons of the Police Department shall continue to be as follows:

SECTION II:

All employees will be hired on a six (6) month probation period.

SECTION III:

If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall affect only such clause, sentence, section or part of this Ordinance and shall not effect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this Ordinance. It is hereby declared to be the intention of the Council of the Municipality of Brookville that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included herein.

SECTION IV:

This Ordinance shall revoke or rescind any Ordinance or Resolution or any part thereof that are in conflict herewith.

SECTION V:

The wage scale as set forth within this Ordinance shall start and be in effect retroactively to January 1, 1981, upon passage of this Ordinance.

SECTION VI:

This Ordinance is hereby declared to be an Emergency Ordinance in order to protect the general health and welfare of the community and its environs. Therefore, this Ordinance shall take effect and be in force from and after its passage by the members of Council, as pursuant to Section 4.07(A)(5) of the Municipal Charter.
