AN ORDINANCE AMENDING ORDINANCE # 348, KNOWN AS THE ZONING ORDINANCE BY ESTABLISHING PERMANENT ZONING CLASSIFICATION FOR NEW TERRITORY IN THE MUNICIPALITY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The permanent classification of R1 as recommended by the majority vote of the municipal planning commission is hereby established for the following newly annexed territory:

Situate in the Village of Brookville, County of Montgomery and State of Ohio, and being all of Lots numbered 1517 through 1529 inclusive and 1531 through 1534 inclusive and 1538 through 1545 inclusive and 1547 of the revised and consecutive number of lots of the said Village of Brookville, Ohio.

SECTION II:

The permanent zoning classification of R2 as recommended by the majority vote of the municipal planning commission is hereby established for the following newly annexed territory:

Situate in the Village of Brookville, County of Montgomery and State of Ohio, and being all of Lots numbered 1546 of the revised and consecutive number of lots of the said Village of Brookville, Ohio.

SECTION III:

The permanent zoning classification of B1 as recommended by the majority vote of the municipal planning commission is hereby established for the following newly annexed territory:

Situate in the Village of Brookville, County of Montgomery and State of Ohio, and being all of Lots numbered 1530 and 1535 through 1537 inclusive of the revised and consecutive number of lots of the said Municipality of Brookville, Ohio.

SECTION IV:

This Ordinance shall take effect and be enforced from and after the earliest period allowed by law and shall revoke and rescind any Ordinances, parts of Ordinances, resolutions or parts of resolutions that are in conflict herewith.
