AN ORDINANCE ESTABLISHING A FIRE OPERATING FUND AS PART OF THE GENERAL FUND OF THE MUNICIPALITY OF BROOKVILLE, OHIO AND AMMENDING THE TITLE OF THE FIRE EQUIPMENT FUND TO READ FIRE CAPITAL IMPROVEMENTS FUND (FIRE EQUIPMENT) AND TO DECLARE AN EMERGENCY FOR BUDGETING PURPOSES.

WHEREAS, costs to operate the Fire Department of the Municipality of Brookville, Ohio have continually increased due to inflation, and

WHEREAS, it is necessary for the preservation of the public health, safety and welfare of the residents of the Municipality of Brookville, Ohio to establish a specific Fire Operating Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

A Fire Operating Fund shall be established as part of the General Fund of the Municipality of Brookville for the Expressed purpose of operating the Brookville Fire Department.

SECTION II:

The said Fire Operating Fund shall be partially funded by fifty percent of all monies received by the Municipality of Brookville, Ohio, from payments made pursuant to all fire protection contracts.

SECTION III:

The title of the Fire Equipment Fund shall hereby be amended to read Fire Capital Improvements Fund (Fire Equipment).

SECTION IV:

The remaining fifty percent of the monies received by the Municipality of Brookville, Ohio, of payments made pursuant to fire protection contracts shall be placed in the Fire Capital Improvements Fund (Fire Equipment).

SECTION V:

This ordinance shall rescind any ordinances or resolutions or any parts thereof that may be in conflict herewith.

SECTION VI:

This ordinance is hereby declared to be an emergency ordinance, the reason for the emergency being the need to provide proper funding for the Brookville Fire Department which is necessary to preserve the public health, safety and welfare of the citizens of the Municipality of Brookville, Ohio,
