Ordinance No. 1981-8

AN ORDINANCE AMENDING ORDINANCE NO. 1980-10, SECTION I - AN ORDINANCE INCREASING THE PERIOD OF TIME IN WHICH THE WATER CHARGE MAY BE PAID WITHOUT PENALTY FOR WATER CONSUMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND OTHER USERS, AND DECLARING AN EMERGENCY.

WHEREAS, it is deemed necessary and essential to allow citizens of the Municipality of Brookville more time in which to pay their water bill and it is, therefore, deemed to be an emergency in order to protect the general health and welfare of the Community and its environs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Section I of Ordinance No. 1980-10 - An Ordinance Fixing the Rules and Regulations, Rates and Charges to all Water Consumers of the Municipality of Brookville, Ohio, declaring an emergency be amended as follows:

There will be a penalty of ten percent (10%) of the total water bill added to the water charge if the bill is not paid twenty-five (25) days after the billing date on the water bill. If the water bill is not paid in full within forty five (45) days of the billing date on the water bill, the water service will be shut off. The shut off notice will be mailed to the property owner prior to the shut off date.

In the event that a consumer's water should be turned off due to non-payment, there shall be a ten dollar (\$10.00) charge prior to the water service being restored.

SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance in order to protect the general health and welfare of the Community and its environs. Therefore, this Ordinance shall take effect and be in force from and after its passage provided passage is by at least two-thirds of the members of Council, as pursuant to Section 4.07 (A) (5) of the Municipal Charter.
