Ordinance No. 1981-9

Passed September 1, 1981

AN ORDINANCE AMENDING ORDINANCE NO. 360, SECTION III - AN ORDINANCE INCREASING THE PERIOD OF TIME IN WHICH THE CHARGES FOR THE SANITARY SEWER SYSTEM AND SEWAGE TREATMENT PLANT SERVICE MAY BE PAID WITHOUT PENALTY FOR CONSUMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND OTHER USERS, AND DECLARING AN EMERGENCY.

WHEREAS, it is deemed necessary and essential to allow citizens of the Municipality of Brookville more time in which to pay their sewer bill and it is, therefore, deemed to be an emergency in order to protect the general health and welfare of the Community and its environs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

Section III of Ordinance No. 360 - An Ordinance amending Section I, paragraph 1 and Section III of the Ordinance 296 fixing rates and charges for the sanitary sewer system and sewerage treatment plant service to the Village of Brookville, Ohio, its inhabitants and other users be amended as follows:

There will be a penalty of ten percent (10%) of the total bill for the use of the sanitary sewer system and sewage treatment plant service added to the sanitary sewer system and sewage treatment plant service bill should that bill not be paid twenty-five (25) days after the billing date on the sanitary sewer system and sewage treatment plant service bill. Any sewer bill which has been delinquent for more than forty five (45) days from the date of billing should be certified to the County Auditor and shall become a lien against the property served and shall be collected as general taxes.


## SECTION II:

This Ordinance is hereby declared to be an emergency Ordinance in order to protect the general health and welfare of the Community and its environs. Therefore, this Ordinance shall take effect and be in force from and after its passage provided passage is by at least two-thirds of the members of Council, as pursuant to Section 4.07 (A) (5) of the Municipal Charter.
