Ordinance No. 1981-11

Passed September 15, 1981

AN ORDINANCE AUTHORIZING THE MUNICIPAL CLERK TREASURER TO PAY THE CITY OF DAYTON FOR THE SUPERVISION, CARE, BOARD, HOUSING AND WORKING OF ANY PRISONERS DELIVERED TO THE CUSTODY OF THE CITY OF DAYTON AT THE HUMAN REHABILITATION CENTER, AND DECLARING AN EMERGENCY.

WHEREAS, the Municipality of Brookville has no facilities which are adequate for the confinement of prisoners; and

WHEREAS, the Municipality of Brookville has contracted with the City of Dayton for the supervision, care, board, housing and working of any prisoners delivered to the custody of the City of Dayton from the Municipality of Brookville; and

WHEREAS, it is deemed necessary for the general health, welfare and safety of the community to provide this service, and it is therefore deemed to be an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The Clerk Treasurer of the Municipality of Brookville, **is** hereby authorized to pay to the City of Dayton for the supervision, care, board, housing and working of each and every prisoner delivered to the custody of the City of Dayton by the Municipality of Brookville, pursuant to the terms of any contract entered into with the City of Dayton by the Municipality of Brookville specifically for those purposes, those sums which are specified in any contract by and between the Municipality of Brookville and the City of Dayton for the specific purpose of supervising, caring for, boarding, housing, and working of prisoners from the Municipality of Brookville.

SECTION II:

This Ordinance is hereby declared to be an emergency ordinance in order to protect the general health and welfare of the community and its environs. Therefore, this ordinance shall take effect and be in force from and after its passage provided passage is by at least two-thirds of the members of council, as pursuant to Section 4.07 (A) (5) of the Municipal Charter.
