Ordinance No. 1980-9

Passed September 2, 1980

AN ORDINANCE AMENDING SECTION I, PARAGRAPH I AND SECTION II OF ORDINANCE NO. 360 FIXING RATES AND CHARGES FOR THE SANITARY SEWER SYSTEM AND SEWAGE TREATMENT PLANT SERVICE TO THE MUNICIPALITY OF BROOKVILLE, OHIO, ITS INHABITANTS AND OTHER USERS, AND DECLARING AN EMERGENCY.

WHEREAS, this service and method of charging is necessary for the general health and welfare of the community and it is, therefore deemed to be an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The following shall be the quarterly rates charged by the Municipality of Brookville for services rendered or to be rendered by its sanitary sewerage system to it and to its inhabitants and others, based on water consumption as follows:

First	- The minimum charge for 1300 cubic feet or less per quarter - \$9.50
Next	1300 cubic feet per quarter - 83¢ per 100 cubic feet
Next	1400 cubic feet per quarter - 75¢ per 100 cubic feet
Next	1300 cubic feet per quarter - 70¢ per 100 cubic feet
Next	1300 cubic feet per quarter - 59¢ per 100 cubic feet
Next	1400 cubic feet per quarter - 49¢ per 100 cubic feet
Next	1300 cubic feet per quarter - 45¢ per 100 cubic feet
Next	1300 cubic feet per quarter - 38¢ per 100 cubic feet
Next	1400 cubic feet per quarter - 28¢ per 100 cubic feet
Next	1300 cubic feet per quarter - 21¢ per 100 cubic feet
All over 13,300 cubic feet per quarter	- 14¢ per 100 cubic feet

SECTION II:

There will be a 25% additional fee for users served outside of the Municipality of Brookville, Ohio corporation limits.

SECTION III:

These rates shall start and be in effect on the October 15, 1980 billing for sewer usage during the previous quarter of June through August, 1980.

SECTION IV:

This Ordinance is hereby declared to be an emergency ordinance in order to protect the general health and welfare of the community and its environs. Therefore, this Ordinance shall take effect and be in force from and after its passage provided passage is by at least two-thirds of the members of Council, as persuant to Section 4.07 (A) (5) of the Municipal Charter.

SECTION V:

If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall affect only such clause, sentence, section or part of this Ordinance and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this Ordinance. It is hereby declared to be the intention of the Council of the Municipality of Brookville that this Ordinance would have been adopted has such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
