RESOLUTION 21-12

A RESOLUTION DIRECTING THE BOARD OF ELECTIONS OF MONTGOMERY COUNTY TO PLACE THE OPEN CITY COUNCIL POSITION PREVIOUSLY HELD BY MATTHEW K. SWABB ON THE BALLOT ON NOVEMBER 2, 2021, FOR THE REMAINDER OF THE UNEXPIRED TERM COMMENCING JANUARY 1, 2022, AND CONTINUING UNTIL DECEMBER 31, 2023.

WHEREAS, Matthew K. Swabb was elected on November 5, 2019, to serve as a member of the Brookville City Council for a term commencing on January 1, 2020, to December 31, 2023; and

WHEREAS, Matthew K. Swabb has resigned as a member of the Brookville City Council, and City Council accepted his resignation on July 6, 2021; and

WHEREAS, more than two years remain in the term of Matthew K. Swabb; and

WHEREAS, pursuant to the Section 3.04 of the Charter of the City of Brookville, if a vacancy occurs on City Council at least seven days prior to the date when candidates for the office of Council must file their nominating petitions and more than two years remain in the term of the incumbent who created the vacancy, the person appointed by the Council shall serve until a successor is elected for the unexpired term at the next regular municipal election for the remainder of the unexpired term.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Board of Elections of Montgomery County, Ohio is directed to place on the ballot, in the election to be held on November 2, 2021, the open city council position previously held by Matthew K. Swabb, for the remainder of the unexpired term commencing January 1, 2022, and continuing until December 31, 2023.

SECTION II: The Clerk of Council is directed to certify a copy of this Resolution 21-12 to the Board of Elections of Montgomery County, Ohio and to take all necessary actions to place this open city council position on the ballot for the remainder of the unexpired term.

SECTION III: This Resolution shall take effect immediately after passage of this Ordinance as provided by Section 4.07 (A) (3) of the Charter of the City of Brookville, Ohio.




