A RESOLUTION REAPPOINTING MS. SONJA M. KEATON CITY MANAGER FOR THE CITY OF BROOKVILLE, OHIO, AND ESTABLISHING HER ANNUAL SALARY AND EMPLOYMENT BENEFITS, AND DECLARING IT AN EMERGENCY.

WHEREAS, Ms. Sonja M. Keaton having met the service credit requirements for an Ohio Public Employees Retirement System retirement, is retiring on July 31, 2022; and

WHEREAS, this Council has given public notice as required by law of its intent to rehire Ms. Sonja M. Keaton as Brookville City Manager effective August 1, 2022; and

WHEREAS, a public meeting to consider the rehiring of Ms. Sonja M. Keaton as Brookville City Manager was conducted prior to the regular City Council meeting at the Offices of the City of Brookville on July 5, 2022, at 7:00 p.m.; and

WHEREAS, this Council considers it to be in the best interests of the City of Brookville to retain her experience, qualifications, and leadership, has decided to reappoint Ms. Sonja M. Keaton the City Manager; and

WHEREAS, in order to provide for the usual daily operations of the various departments of the City, and to afford a continuation of orderly management of the City and to comply with all applicable law, it is necessary that this resolution take effect at the earliest possible moment allowed by law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:


SECTION I: Ms. Sonja M. Keaton is reappointed City Manager of the City of Brookville, Ohio effective August 1, 2022. Ms. Keaton shall continue to receive her current salary and benefits on file with the Department of Finance and hereby approved.

SECTION II: Ms. Sonja M. Keaton shall receive all other benefits, including salary increases, authorized by Council by the appropriate legislation or Council action.

SECTION III: This resolution is passed as an emergency measure for the protection and preservation of the peace, health, safety, and general welfare of the inhabitants of the City, the emergency is to provide for the usual daily operations of the various departments of the City, and to afford a continuation of orderly management of the City. This Resolution shall take effect immediately upon passage by two-thirds of the members of Council of the City of Brookville, Ohio.
