

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
July 18, 2000

The Regular Meeting of the Brookville Municipal Council was called to order by Mayor Dafler at 7:30PM on July 18, 2000, in the Municipal Council Room. Members Duncan, Garber, Imler, Shellabarger and Trimble, Manager Wright, Assistant Manager Sewert, Law Director Stephan and Deputy Clerk Brunner were present. Member Seagraves and Clerk Keaton were absent.

Motion by Duncan, second by Imler to accept the Agenda with an addition. All yeas, motion carried.

Motion by Duncan, second by Imler to accept the July 5, 2000 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments: Dave Monnin, representing MDA, requested that they be allowed to block off Market Street (for a classic car show) from the intersection of Wolf Creek Street north on Market Street, to the front of Brookville Aluminum, both sides of Walnut Street from alley to alley. Hours requested are 8AM to no later than 7PM on August 20, 2000. The side street will be left open for the fire department. Port-a-Jons will also be placed in the area. Monnin will check with the minister at the New Testament Baptist Church so as not to disturb their parking.

Monnin also requested permission to have a beer garden & pig roast in the Parking Lot of Hatmaker's Garage (on the corner of Wolf Creek Street & Market Street). The area will be roped off, ID's checked, and no children will be permitted in the Pig Roast (roped off area). The liquor license can be obtained through O'Riley's and has already been applied for.

Questions and answers followed.

Motion by Garber, second by Dafler to allow Dave Monnin (MDA) to proceed as presented. All yeas, motion carried.

Dave Monnin, representing the Chamber of Commerce, gave an update on the parking for the Community Picnic and asked permission to place temporary stop signs and a crosswalk at the entrance of Golden Gate Park on East Upper Lewisburg-Salem Road. Dor-Ray has given permission for parking in the open field across the street. The Masons will be patrolling the area and the crosswalk.

Members of Council suggested a temporary flashing sign of some sort, Manager Wright was in agreement and also suggested a temporary stop ahead sign to slow traffic before the crosswalk. Manager Wright will take care of the area for the Community Picnic.

Manager Wright gave his report with the following action taken.

Manager Wright requested permission to advertise for bids for the Street Resurfacing Project. He reported that we have approximately \$60,000 appropriated, and stated that he could bring bids back to Council in approximately three weeks for approval.

Motion by Imler, second by Duncan to authorize Manager Wright to advertise for bids for the 2000 Street Resurfacing Project. All yeas, motion carried.

Manager Wright also reported that the Fire Department had applied and received a grant for approximately \$17,417.00, \$16,000 to be used for training and approximately \$600 for patient care. Member Wright commended Chief Nickel and Asst. Manager Sewert for their work on the grant.

Manager Wright reported that he had heard concerns about the Fireworks Display planned for the Community Picnic and wanted to assure Council that he has had meetings with the Police & Fire Departments and all precautions have been taken. He has also met with the Municipality's insurance carrier and they are satisfied with the coverage offered by the Fireworks' Company.

The Rock Street Project is going well. The new water main is installed and the services have been transferred to the new main. The storm sewer will be completed in the next day or so, then they will start tearing up blacktop. Concrete is scheduled for August 8th for the curbs and sidewalks and the project should be completed by mid August.

Manager Wright received correspondence from 5 Rivers Metro Parks and asked if Council would like them to come to Council and give a presentation to support the upcoming levy in November and if Council would be interested in endorsing the levy with a resolution. Consensus was that Council would like to hear the presentation and then decide if they will endorse the levy. Manager Wright will make contact with 5 Rivers Metro Parks and set up a date for them to make a presentation to Council.

Council inquired if the lot on the corner of Western & Hill has been sold. Mr. Monnin stated that it is sold.

Member Duncan addressed Dave Monnin as President of Park Board, and reported that he has received complaints about smoking & animals in the Castle area. Dave Monnin stated that there are already "No Smoking" signs in place. Manager Wright agreed to place "No Pets" signs in the Castle area.

Law Director Stephan had no report.

Member Garber inquired if we have any news on the Traffic Study. Asst. Manager Sewert replied that we should receive the revised traffic study within the next two weeks and a presentation to follow within a month.

Member Garber also inquired if we were in violation of state law by declaring emergency resolutions, Law Director Stephan replied that we are not in violation as we are within the guidelines of our Charter.


Finance Director/Clerk Keaton was on vacation, no report was given
