

BROOKVILLE CITY COUNCIL
SPECIAL MEETING
"YOUTH-IN-GOVERNMENT"
BROOKVILLE HIGH SCHOOL AUDITORIUM, 7:30 P.M.
May 31, 2001

The Special Meeting of the Brookville City Council was called to order by Mayor Dafler at 7:30 P.M. on May 31, 2001 in the Brookville High School Auditorium.

Mayor Dafler welcomed everyone and introduced the "Youth-In-Government" officials and presented Certificates of Merit as they assumed their positions from the regular officials.

Members Duncan, Imler, Seagraves, Shellabarger and Trimble; Manager Wright, Assistant Manager Sewert, Law Director Stephan, Lieutenant Batz and Police Sergeant Hutton were present. Member Garber was absent.

Motion by Seagraves, seconded by Imler to accept the Agenda with an addition under Citizens Comments, Mark Brown. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the May 15, 2001 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments: Mark Brown, Brookville High School Government Teacher, gave a brief overview of the "Youth-In-Government" program, and this being the 26th year of participation.

Mike Dull, of Clay Township, asked Mark Brown what the future held for the "Youth-In-Government" program. Mr. Brown indicated with new requirements for the present sophomore class, the continuation of the program is uncertain. The program should continue for the next two to three years.

The Youth-In-Government Manager Tipton presented his report on the Clay Street Project with the following action taken.

Motion by Imler, seconded by Seagraves to accept the low bid from Butler Asphalt Company, of \$16,966.32 for the Clay Street Reconstruction Project-Asphalt Paving as the lowest and best bid as recommended by Manager Wright, and to accept the low bid from Balsbaugh Construction of \$35,931.85 for the Clay Street Reconstruction Project-Concrete Installation as the lowest and best bid as recommended by Manager Wright. All yeas, motion carried.

The Youth-In-Government Manager reported the city received notice, from the State of Ohio, that we have been approved for funding under the Small Governments Committee in the amount of \$220,000, for the Western Avenue Reconstruction, Phase I Project, which will probably occur sometime next year.

Reports were given by the various Youth-In-Government officials with no additions to the reports by the regular officials and no action taken.


The Youth-In-Government Mayor Watkins read a letter that was sent by the Department of the Treasury, Bureau of Alcohol, Tobacco and Firearms, which informed the city that Detective Gary Hutton and Fire Chief Nickel have been selected to receive the Bureau of Alcohol, Tobacco and Firearms' (ATF) Director's Award. The award recognizes outstanding and exceptionally significant service in the public interest. On June 12, 2001, Detective Hutton and Fire Chief Nickel will be presented with the Director's Award, which will be held in Washington, D.C.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 01-04. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the first reading of proposed Resolution No. 01-04. All yeas, motion carried.

The "Youth-In-Government" Council asked the regular Council to look into the placement of directional signs for Brookville High School off the exit of Interstate 70, with the Class of 2001 paying the expense of the signs. Manager Wright will look into this. Another request is to backup all four turn lanes at the intersection of Arlington and Triggs Roads. Manager Wright and the Police Department will look into this. The last request is for the Law Director and the Police Department to look at prohibiting rollerblading on public streets.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
