SPECIAL MEETING
“YOUTH-IN-GOVERNMENT”
BROOKVILLE HIGH SCHOOL AUDITORIUM, 7:30 P.M.
May 30, 2002

The Special Meeting of the Brookville City Council was called to order by Mayor Imler at 7:30 P.M. on May 30, 2002 in the Brookville High School Auditorium. The Pledge of Allegiance was recited.

Mayor Imler welcomed everyone and introduced the “Youth-In-Government” officials and presented Certificates of Participation as they assumed their positions from the regular officials.

Members Duncan, Garber, Sanders, Seagraves, Trimble and Ullery; Manager Wright, Assistant Manager Sewert, Law Director Stephan, Fire Chief Nickel and Police Chief Papanek were present.

Motion by Duncan, seconded by Sanders to accept the Agenda as presented. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to accept the May 21, 2002 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments: Mark Brown, Brookville High School Government Teacher, gave a brief overview of the “Youth-In-Government” program, and this being the 27th year of participation.

The “Youth-In-Government” Manager Corder gave her report with no action taken.

The “Youth-In-Government” Assistant Manager Stephan gave her report with no action taken.

The “Youth-In-Government” Police Chief Daniels gave her report with no action taken.

The “Youth-In-Government” Fire Chief Jones gave her report with no action taken.

The “Youth-In-Government” Law Director Trangenstein gave his report with no action taken.

The “Youth-In-Government” Finance Director/Clerk Gordon gave her report with the following action taken.

Motion Duncan, seconded by Garber to set a Public Hearing for July 2, 2002 at 8:00 p.m. for the 2003 Tax Budget. All yeas, motion carried.

Motion by Duncan, seconded by Sanders to read proposed Ordinance No. 2002-06. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 2002-06 entitled “AN ORDINANCE TO APPROVE AND ADOPT CURRENT REPLACEMENT PAGES TO THE CODIFIED ORDINANCES, AND DECLARING AN EMERGENCY.” All yeas, motion carried.

The “Youth-In-Government” Mayor Casey gave his report with no action taken.

Motion by Trimble, seconded by Ullery to read proposed Resolution No. 02-17. All yeas, motion carried.



Motion by Duncan, seconded by Sanders to accept the first reading of proposed Resolution No. 02-17. All yeas, motion carried.

Motion by Seagraves, seconded by Garber to read proposed Resolution No. 02-18. All yeas, motion carried.

Motion by Sanders, seconded by Duncan to accept the first reading of proposed Resolution No. 02-18. All yeas, motion carried.

The "Youth-In-Government" Council asked the regular Council to look into paving the alleys surrounding the school parking lot. Assistant Manager Stephan stated this would be a good idea, but it may cause people to speed through the alleys; maybe speed bumps could be added to alleviate any speeding. Another request was to change the speed limit along East Westbrook Road to 35 MPH from the current 25 MPH. Police Chief Papanek stated there were several reasons for implementing the 25 MPH speed limit, all of them relating to safety issues. Another request was to place a traffic signal at the Arlington Road and W. Upper Lewisburg Salem Road intersection. Manager Wright indicated we are currently in the preliminary phase of realigning the intersection. He also indicated a traffic survey will be conducted in the near future to see if that intersection warrants a traffic signal. Another request was to place a traffic signal on Arlington Road by McMaken's entrance. Manager Wright indicated that did not warrant a traffic signal. Another request was to implement specific hours on the school speed limit signs, versus the current wording of "during restricted hours." Council and the Department Heads will take the suggestions under consideration.

Motion by Garber, seconded by Sanders to adjourn. All yeas, motion carried.
