**A RESOLUTION AUTHORIZING THE CITY OF BROOKVILLE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND / OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED.**

**WHEREAS**, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

**WHEREAS**, the City of Brookville is planning to make a water main replacement project on Main Street between Columbia and Salem Streets; and

**WHEREAS**, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:**


**SECTION I:** The City Manager is hereby authorized to apply to the OPWC for funds for a water main replacement project on Main Street between Columbia and Salem Streets; and

**SECTION II:** The City Manager is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

**SECTION III:** This Resolution shall take effect immediately and be in force thirty (30) days after passage as provided by the Charter of City of Brookville.
