

RESOLUTION NO. 24-34

A RESOLUTION AMENDING THE 2024 APPROPRIATIONS, AS SET FORTH BELOW, PURSUANT TO SECTION 5705.40 OF THE OHIO REVISED CODE, AND SECTION 12.35 OF THE OHIO ADMINISTRATIVE CODE AND APPROVING THE AMENDMENT TO THE CERTIFICATE OF ESTIMATED RESOURCES, AS SET FORTH BELOW.

WHEREAS, the Council of the City of Brookville, Ohio approved the 2024 Original Certificate of Estimated Resources and the 2024 Appropriation Resolution; and

WHEREAS, the City of Brookville, Ohio needs to comply with the 2024 Budget; and




