

ORDINANCE 2025-13

AN ORDINANCE ESTABLISHING A CHARTER REVIEW COMMISSION IN THE CITY OF BROOKVILLE, OHIO.

WHEREAS, Section 7.06 of the Charter of the City of Brookville provides that the City Council may create boards and commissions as it determines to be necessary, and may provide for their organization, membership, method of appointment, terms of office of members, and powers, duties and functions by ordinance or resolution; and

WHEREAS, the City Council desires to establish a Charter Review Commission to review the Charter of the City of Brookville, and to make recommendations to City Council regarding any proposed amendments to the Charter of the City of Brookville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:


SECTION I: The City Council hereby establishes a Charter Review Commission to review the Charter of the City of Brookville and to make recommendations to City Council regarding proposed amendments to the Charter of the City of Brookville. The Charter Review Commission shall consist of seven (7) members appointed by motion approved by a majority of the members of City Council. Members of the Charter Review Commission shall serve a term of one (1) year. All meetings of the Charter Review Commission shall be open to the public and shall be subject to the provisions of the Ohio Public Records law. The Charter Review Commission shall be organized in compliance with Section 7.07 of the Charter.

SECTION II: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION III: This Ordinance shall take effect thirty (30) days after passage by the Council of the City of Brookville as provided by the Charter of the City of Brookville.




