Ordinance No. 2024-12 Passed September 17, 2024

## AN ORDINANCE ESTABLISHING BUSINESS REGISTRATION IN THE CITY OF BROOKVILLE, OHIO.

**WHEREAS**, the City of Brookville is currently attracting many new businesses; and

**WHEREAS**, the City of Brookville desires to require businesses to register with the City of Brookville prior to the business commencing operations in the City of Brookville to provide the City with information regarding the business and to assist the City in determining that the business has obtained all necessary permits and licenses to operate the business;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:**

**SECTION I:** The Council of the City of Brookville hereby adopts Chapter 705 entitled Business Registration as follows:

### CHAPTER 705. BUSINESS REGISTRATION

705.01 Business Registration: All businesses that are located in the City of Brookville and commence operations in the City of Brookville after October 30, 2024, shall register the business with the City of Brookville. The City Manager shall approve a business registration form to be used in the registration process.

705.02 Penalty: The failure of the owner of a business to register the business with the City of Brookville shall constitute a minor misdemeanor.

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and all deliberations of this Council were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


**SECTION III:** This Ordinance shall take effect thirty (30) days after passage as provided by the Charter of the City of Brookville, Ohio.




