August 5, 1997

The Regular Meeting of the Brookville Municipal Council was called to order by Mayor Dafler at 7:30PM on August 5, 1997 in the Municipal Council Room. Members Duncan, Garber, Seagraves, Shellabarger and Trimble; Manager Wright and Law Director Stephan were present. Member Imler was absent.

Motion by Seagraves, seconded by Shellabarger to accept the Agenda as presented. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the July 15, 1997 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments: Dottie Watkins, on behalf of the Chamber of Commerce, thanked the City for helping with the Community Picnic. Discussion followed.

Manager Wright gave his report with the following action taken.

Manager Wright introduced Trent Weaver with the Wildlife Service, there was discussion on wild animals and suggestions given on various ways of handling situations; questions and answers followed.

Mayor Dafler gave his report with no action taken.

Motion by Seagraves, seconded by Duncan to read proposed Resolution No. 97-14. All yeas, motion carried.

Motion by Duncan, seconded by Trimble to accept the first reading, dispense with the second and third reading and adopt Resolution No. 97-14 entitled "A RESOLUTION DECLARING THE NECESSITY OF CONSTRUCTING, REPLACING OR REPAIRING CERTAIN SIDEWALKS, CURBS AND GUTTERS IN THE

MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING IT AN EMERGENCY". All yeas, motion carried.


