February 4, 1997

Motion by Imler, seconded by Seagraves to accept the Agenda as corrected. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the January 21, 1997 Regular Meeting Minutes as presented. All yeas, motion carried.

Motion by Duncan, seconded by Imler to accept the January 31, 1997 Fund Balance as presented. All yeas, motion carried.


Mayor Dafler gave his report with no action taken.
