

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
October 7, 1997

The Regular Meeting of the Brookville Municipal Council was called to order by Mayor Dafler at 7:30PM on October 7, 1997 in the Municipal Council Room. Members Garber, Imler, Seagraves, Shellabarger and Trimble; Manager Wright and Law Director Stephan were present. Member Duncan was absent.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented with corrections. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the September 16, 1997 Regular Meeting Minutes as presented. All yeas, motion carried.

Citizens Comments: Charles Britton expressed unhappiness with the noise from cars, trucks and boom boxes. Discussion followed with no action taken.

Manager Wright gave his report with the following action taken.

Motion by Imler, seconded by Seagraves to authorize the High School Homecoming Parade starting at 6:30PM on Thursday October 9, 1997; with the route being the same as in the past. All yeas, motion carried.

Motion by Imler, seconded by Trimble to accept the bid from Waste Management of \$2.06 per residence for curbside recycling, as recommended by Manager Wright as the lowest and best bid, starting at the end of the present contract. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to authorize entering a contract with DP&L for street lighting, starting January 1, 1998 for three (3) years. Garber abstained, balance yeas. Motion carried with five yeas and one abstention.

Law Director Stephan gave his report with no action taken.

Finance Director Roeser gave his report with the following action taken.

Motion by Imler, seconded by Seagraves to accept the September 30, 1997 Fund Balance as presented. All yeas, motion carried.

Mayor Dafler recessed Council for the Public Hearing.

Clerk Roeser reported on the request for rezoning from "C" to "R-2", of the property as listed on proposed Ordinance No. 1997-07; as Manager Wright showed an overhead of the area and printed out locations. He reported that 17 letters were sent out to adjoining property owners and advertised in the Brookville Star. Three calls were received in the office, two of them being from the owner of the property being changed. There were no objections from phone calls or citizens present for the hearing.

Clerk Roeser went over proposed Ordinance No. 1997-08 to change Section 1157.04 covering patios, porches, carports and canopies, which are changes requested by the Planning Commission to clarify some existing problems. This was advertised in the Brookville Star and no calls were received in the office and there were no objections by the citizens present at the Public Hearing.

Mayor Dafler ended the Public Hearing and called Council back into Regular Session.

Mayor Dafler gave his report with the following action taken.

Mayor Dafler presented a new Municipal Flag to Dottie Watkins for the Brookville Historical Society.

There was discussion on a request from the Booster Club to put up streamers with the school colors around town and on the parade route. Consensus was that this would be OK but no streamers are to be placed on any steel posts or fixtures.


Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1997-09. All yeas, motion carried.


Motion by Imler, seconded by Garber to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1997-09 entitled "AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE CONSTRUCTION REPAIR AND REPLACEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING IT AN EMERGENCY". All yeas, motion carried.

Motion by Seagraves, seconded by Imler to read proposed Ordinance No. 1997-10. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1997-10 entitled "AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE CONSTRUCTION REPAIR AND REPLACEMENT OF CURBS AND GUTTERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING IT AN EMERGENCY". All yeas, motion carried.

Motion by Imler, seconded by Garber to adjourn. All yeas, motion carried.
