

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
October 21, 1997

The Regular Meeting of the Brookville Municipal Council was called to order by Mayor Dafler at 7:30PM on October 21, 1997 in the Municipal Council Room. Members Duncan, Imler, Seagraves, Shellabarger and Trimble; Manager Wright and Law Director Stephan were present. Member Garber was absent.

Member Seagaves introduced a couple Boy Scouts working on merit badges.

Mayor Dafler welcomed four High School Students attending for their Government classes.

Motion by Imler, seconded by Seagraves to authorize a send off parade for the Brookville Band on October 26, 1997 at approximately 11:00AM, with limited use of sirens due to church services. All yeas, motion carried.

Manager Wright gave his report with no action taken.

Finance Director Roeser gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to accept the recommendation of the Park Board and appoint Dave Poynter (one of the four persons indicating interest in the position) to the Park Board position that will be open upon President Pettit moving out of the Municipality. All yeas, motion carried.

Mayor Dafler gave his report with no action taken.

Clerk Roeser reported that the Planning Commission recommended that Ordinance Nos. 1997-07 and 1997-08 be adopted by Council.


Motion by Imler, seconded by Seagraves to read proposed Ordinance No 1997-07. All yeas, motion carried.

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1997-08. All yeas, motion carried.


Motion by Imler, seconded by Duncan to accept the second reading of proposed Ordinance No. 1997-08. All yeas, motion carried.
