

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
July 16, 1996

The Regular Meeting of the Brookville Municipal Council was called to order by Mayor Dafler at 7:30 PM on July 16, 1996 in the Municipal Council Room. Members Duncan, Garber, Imler, Trimble; Manager Wright and Law Director Stephan were present. Member Seagraves arrived later, and Member Shellabarger was absent.

Motion by Duncan, seconded by Imler to accept the Agenda as presented with addition. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the July 2, 1996 Regular Meeting Minutes as presented. All yeas, motion carried.

Member Seagraves arrived.

Citizens Comments:

Owen Williams on behalf of the Brookville Teen Task Force, requested approval for a teen march. Discussion followed.

Motion by Imler, seconded by Trimble to approve the "Follow Me Drug Free March" from the High School to Golden Gate Park on July 27, 1996 at 11:00 AM, as requested. All yeas, motion carried.

Russ Rhoades complained on weeds in the Arlington Woods Subdivision and also Brookville Stor-N-Lock not having a drive and lot blacktopped off of Albert Road. Manager Wright will check into both complaints.

Manager Wright gave his report with the following action taken.

Don Bowman presented plans and specs for the Wolf Creek Pike Road Improvement Project from Westbrook Road South. Discussion followed.

Motion by Segraves, seconded by Imler to approve the plans, specs and estimates for the Wolf Creek Pike project as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to authorize a No Parking area in front of Benchmark Homes Office on Hay Avenue for safety reasons, as requested. All yeas, motion carried.

Mayor Dafler gave his report with no action taken.


Motion by Seagraves, seconded by Trimble to read proposed Resolution No. 96-14. All yeas, motion carried.


Motion by Seagraves, seconded by Imler to read proposed Ordinance No. 1996-04. All yeas, motion carried.
